REPLY TO PLAINTIFFS' RESPONSE TO MOTION TO DISMISS

Defendants/Counter-Plaintiffs, Maurice Tose' and Teresa Layden (hereinafter "Tose" or "Defendants"), by and through their attorneys, Barbara J. Palmer and Hyatt & Weber, P.A., file this Reply to Plaintiffs' Response to the Motion to Dismiss and state:

1. Plaintiffs, in their Response to the Motion to Dismiss filed December 21, 2021, acknowledge that they are attempting to expand the scope of the pending litigation from dealing *solely with the property contiguous with the Tose' Property* to including *all of the platted streets in Arundel on the Bay* by adding an additional paragraph to its First Amended Complaint.¹

2. The Amended Complaint was required in order to add all property owners in Arundel on the Bay as necessary parties in compliance with the Order dated June 14, 2021; however, Plaintiffs are apparently attempting to use the opportunity to change the scope of the

litigation, in an effort to assert a claim to title to “all platted streets in Arundel on the Bay or portions thereof...” except those previously determined by court order. (§ 23 of Plaintiffs’ Amended Complaint)

3. However, because the Plaintiffs did not redefine the geographical area of their claim in the ad damnum clause of the Amended Complaint (other than to include a portion of property contiguous to the Tose’ Property referred to as the Site Area) this Court may not made a determination regarding property beyond the scope of the requested relief.²

3. Plaintiffs’ Response points out Defendants’ deficiencies, indicating that the undersigned had ample opportunity to comprehend the shift in the scope of the litigation set forth in the Amended Complaint, prior to the preparation of the September 7, 2021 Joint Motion for Alternate Service. (See Plaintiffs’ Response ¶ 15.)

4. Plaintiffs’ Response argues that the documents served upon the community members are self-explanatory, that the notification “completely and accurately reflects the claims in the case” and that they have done nothing to discourage parties from participating (See Response ¶ 15), while in fact, Plaintiffs have taken numerous steps to provide assurances that the present litigation concerns the property contiguous to the Tose’ property, only, and that the property owners need not take any action in response to the litigation.

5. Contrary to the Plaintiffs’ statements in its Response, there are multiple statements contained in communications to, and/or available to the community members that are misleading regarding the scope of the litigation, leading one to believe that the only property at issue is that area contiguous with the Tose’ Property. These statements include, but are not limited to:

A. The Joint Motion for Alternate Service, which states that the action involved claims for use and possession of the “Subject Property” defined as “an area of a paper road in the vicinity of property owned by the Defendants, Maurice Tose’ and Teresa Layden”; (Joint Motion ¶ 1.) and

B. The Notification of Order of Court to Join Necessary Parties, which was served upon each property owner states specifically: “[o]n November 8, 2019, the Plaintiffs filed an action to Quiet Title against Defendants, to address *issues related to the paper road located on Magnolia Avenue, near its intersection with Saratoga Avenue*. Plaintiffs sought an order declaring that the Plaintiffs and all lot owners within Arundel on the Bay *have an implied easement to use this Disputed Street;*” and

C. The September 16, 2021 email to All AOTB Property Owners which states: “Maurice Tose began making changes to *Magnolia Avenue near his residence at 1299 Magnolia...the areas of Magnolia and Saratoga Avenues at issue...*” See, Exhibit A hereto, the September 21, 2021 Email to All AOTB Property Owners from the Legal Advocate, Susan Cook, who, as of her April 28, 2021 deposition, was a practicing attorney with Plaintiffs’ counsel, Council Baradel)

6. If Plaintiffs’ goal is to use this litigation in order to claim title to all platted streets throughout the community via a deed or adverse possession as stated in Paragraph 23 of Plaintiffs’ Amended Complaint, then this claim should be clearly stated at the outset, so that all concerned parties would understand the potential impact on their own property, and service of process—in full compliance with the Maryland Rules of Procedure—should occur without compromise or short cut, so that the property rights of all community members would be adequately protected.

7. Defendants were originally supportive of an abbreviated form of service of process because they erroneously understood that, as stated in the Joint Motion, the action only involved the claims of use and possession of the property contiguous to the Tose' Property, which is referred to in the Joint Motion as the "Subject Property"; and as a result of the undersigned's prior involvement in the 2015 case of *Atterbeary, et al. v. Property Owners Association of Arundel on the Bay, Inc.*, Case No. C-02-CV-15-003736, the individual community members did not express an interest in the availability of the use of the *specific property at issue*.

8. To the extent that the undersigned misconstrued that the scope of this action remained limited to the "Subject Property"—i.e., only that property contiguous to the Tose' Property—and therefore believed an abbreviated procedure for service of process would suffice, the undersigned accepts that responsibility.

9. However, there has been decades of litigation involving this Plaintiff, Property Owners Association of Arundel on the Bay, Inc., dating at least back to the mid-1990's, against property owners within the community over specific portions of paper roads; none of which resulted in an effort to claim title or use of platted paper roads throughout the entire community.

10. These cases include, but are not limited to: *Atterbeary, et al. v. Property Owners Association of Arundel on the Bay, Inc.*, Case No. C-02-CV-15-003736; *Property Owners Association of Arundel on the Bay, Inc. v. McManus, et al.*, Case No. 02-C-05-105032; *Bellamy, et al. v. Property Owners Association of Arundel on the Bay, Inc.*, Case No. 02-C-06-115184; *Kelly, et al. v. Property Owners Association of Arundel on the Bay, Inc.*, Case No. 02-C-07-123404; *Property Owners Association of Arundel on the Bay, Inc. v. Durant, et al.*, Case No. C-95-24605; see also the recorded agreement involving *Sockwell, et al. and Property Owners*

Association of Arundel on the Bay, Inc., in which title to the subject property was never resolved but a use agreement was reached and recorded.

11. It has always been the intention of the Defendants to obtain finality as to the rights of the Association and all necessary parties as it relates to any claim of ownership or use of the *Subject Property, contiguous to the Tose' property, as it has been defined in this litigation, only.*

12. Defendants assert that an alternative method for service of process on community property owners, in an action which may result in a judgment affecting their individual property rights, to title to, or use of, property associated with their residential lots, would be inappropriate; was never the intention of the undersigned; nor is it fair to the other property owners within the community of Arundel on the Bay.

13. Defendants anticipated that the modified service of process would assure that all named parties received notice of the action and that most of the necessary parties would opt out of the litigation, some would participate, and to assure notice in the face of this modified service, a default would be obtained, in order to assure finality of judgment.

14. However, as of the filing of this Reply, despite the efforts of Defendants to obtain service of process and the feedback of the necessary parties, of the Three Hundred Eighty-Four (384) property owners served through the modified service of process, only One Hundred Thirty-Nine (139) property owners—about one third—have provided a Line to Opt Out of the action. (See, Exhibit B, the tally of all property owners in the community, the service of process results known to the Defendants, and the Lines to Opt Out provided to both Plaintiffs' and Defendants' counsel.)

15. Although the Notification and the Consent Order delivered to the community members indicate that they have been added as parties to the litigation and direct that they are to

execute the Line to Opt Out to indicate that they agree to be bound by the outcome, or participate in the proceedings, the Association emailed all of its members and necessary parties and instructed that they need not respond to the service and that “*there is nothing you need to do in response.*” See Exhibit A, the September 16, 2021 email from the “Legal Advocate of Arundel on the Bay.”

16. The information provided by the Plaintiff Association, through its Legal Advocate, and perhaps through other means, is directly contradictory to the Notification and Order for Alternate Service, and has led to a lack of response by the necessary parties in this action.

17. To the extent that Plaintiffs are intent on obtaining a declaratory judgment in this action regarding title to and use of extensive but undefined property in the community of Arundel on the Bay, this effort should fail as it is not in accordance with the requirements set forth in the MD Code, Real Property Title 14, Subtitle 6 addressing Actions to Quiet Title and such was not conveyed to the necessary parties.

18. In addition, the abbreviated procedure for service of process failed to obtain the required result of a conclusive method of obtaining finality in any judgment reached herein.

For all the reasons set forth herein, Defendant respectfully requests that this Court direct that the scope of this action is specifically restricted to a determination of the rights, title and interest of the Disputed Street and Site Area contiguous to the Tose’ Property (the “Subject Property”) or in the alternative, that Plaintiff be required to properly serve all necessary parties in accordance with the Maryland Rules of Procedure if the outcome of this action could determine property rights to property beyond the scope of this action.

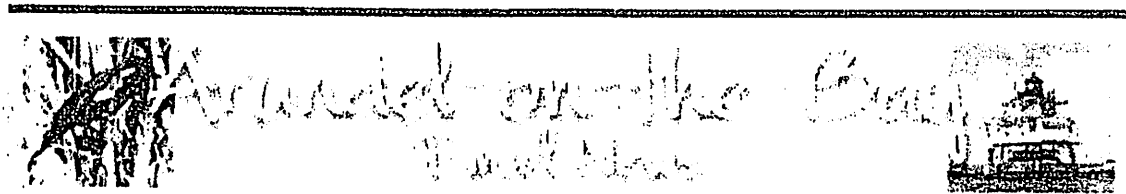

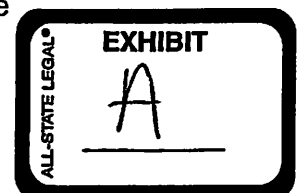

To All AOTB Property Owners:

The mailing you received today is related to the Tose litigation. You are not being sued and there is nothing you need to do in response. Later we will have more information for you; we were waiting for the Judge to enter this order which tells us what we need to do.

Background: In late 2018, Maurice Tose began making changes to Magnolia Avenue near his residence at 1299 Magnolia. These changes included enlarging the roadway by placing gravel where there formerly was grass, and by placing obstructions in the roadway. The areas of Magnolia and Saratoga Avenues at issue have been maintained by AOTB and regarded as community-owned roads for over 70 years.

Our efforts to negotiate removal of the obstructions were unsuccessful and in late 2019 the Association sued Mr. & Mrs. Tose (the property is jointly-owned, hereinafter "Mr. Tose") requesting removal of obstructions and the cessation of attempts to change the condition of our roadways or to block passage on those roads to vehicles or pedestrians. In response, Mr. Tose



counter-sued, claiming ownership of Magnolia Avenue from Saratoga Avenue west to Fishing Creek and to 1/2 of Saratoga Avenue from its intersection with Magnolia Avenue south to the water.

This matter was scheduled to go to trial last May. Shortly before trial, Mr. Tose moved to join all property owners to the litigation. Trial was then continued to March 2022 and the parties began negotiating the details of the joinder procedure.

Tose' Motion to Join Property Owners: The parties have agreed upon a procedure by which members of the community will be offered the opportunity to join the litigation if they wish. If a property owner is comfortable with the way the Association is representing the community's interests, there usually would be no reason for a property owner to individually join the litigation. The Association's attorneys have been and will continue to represent the interests of the Association and to protect the Association's interest in its roads on behalf of the community.

We were not aware the document you received today was going to be mailed to property owners before we would have had an opportunity to provide you with information. Shortly we will be providing you with additional information and we will be posting documents on the website to keep you fully informed. You will have the opportunity to join the litigation if you wish but you will not be required to do so. The Judge will decide the case based on the law – not on how many members of the community have joined the litigation.

Again, you are not being sued and there is nothing you need to do in response to the document you received. Later we will have more information for you; we were waiting for this order to be able to move forward.

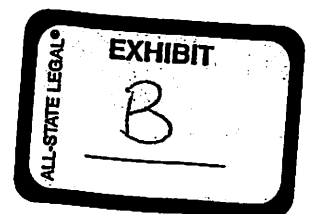
